cars according to RDS Article 2 (2022 Italian Rallycross Championship).

5. RUNNING OF THE EVENT

There will be 4 qualifying Heats with maximum 5 cars starting abreast in each race over 4 laps.
There will be 6 laps in the Semi-/Finals.

Heats and Semi-Finals will be driven together.

At the end of the Finals, the final results will be split for the different Championships;
points and prizes will be allocated according to the different regulations.

6. FEES

The entry fee for the FIA CEZ RX Championship will be: 244,-€ (Italian VAT + paddock fee included)

The entry fee for the Italian Rallycross Championship will be: 300,-€ (+ Italian VAT)

A Competitor has to pay **only one entry fee**.

As the entry form from the Driver and the confirmation of the acceptance from the organiser is considered as a contract, the Driver, not coming to the Competition, has to apologise giving the reason as soon as possible.

7. INSURANCE

The entry fee includes Third Party insurance. The Organising Committee stipulates an insurance for Third Party risks as per the conditions laid down in the Italian law and by the ACI-SPORT (Allianz).
The original copy of the insurance contract will be available at the event.

8. PROTEST AND APPEALS

8.2 All protests will be lodged in accordance with the Code.

All protests must be made in writing and handed to the clerk of the course or his assistant, or in their absence any of the stewards of the meeting, together with the sum of 350,-€.

If the protest requires the dismantling and re-assembly of different parts of a car, final fee to be set according to ACI-SPORT Yearbook 2022.

A summary of the protest fees will be posted at the Official Notice Board of the event (online).

9. PRIZES

The Prize Giving for all Divisions will take place in the paddock after results will be official.

The winners of the 1st, 2nd and 3rd prizes must be present, wearing their race overalls.

10. OTHER INFORMATION

10.1 FIRE EXTINGUISHERS

Each Driver is responsible for ensuring that a single piece extinguisher of minimum 5 kg is available within his own team area inside the paddock.

10.2 PROTECTION OF THE ENVIRONMENT

Each driver is requested to ensure that a plastic sheet (minimum dimensions 4 metres by 5) is spread on the ground in the place reserved for his team where work is to be done on his car, in order to prevent any pollution in case of an accidental leak, etc.
